<b>Subject:</b>	Consolidated Trade Summary (CTS) Rewrite SMART/Search Print Image Closure

In June, 2017 the National Securities Clearing Corporation (NSCC) transitioned the Consolidated Trade Summary (CTS) legacy files to the new CTS format. At the time, to support a smooth industry conversion to the new output NSCC temporarily continued production of the CTS print image report in SMART/Search. With the conversion successfully completed NSCC will retire the CTS rewrite SMART/Search report on August 30, 2018.

While there is not a direct replacement for Print Image users, multiple version of CTS output are available for customers. CTS data is reported in the Clearing Dashboard or by receipt of MRO or CSV files. Details of each are outlined below.

#### Clearing Dashboard

Through the Clearing Dashboard, customers will have access to CTS information ranging from netting disposition totals to transaction-level details. Users must have access to the “CLD User” and “CTS Inquiry” in order to view the CTS dashboard. Below is a description of these roles that can be assigned by the SAC or Access Coordinator.

Entitlement	Role	Description
CLD	CLD User	Allows user to access Clearing Dashboard from portal
CTS	CTS Inquiry	Allows user to access CTS inquiry functions
